289.2129 Certified Manager Required

(1) All of the following food establishments shall employ a minimum of 1 managerial employee who is currently certified under a personnel certification program accredited by the American national standards institute, utilizing the conference for food protection standards: (a) A food service establishment that is not any of the following: (i) Operating under a temporary food service establishment license. (ii) A vending machine location. (b) An extended retail food establishment. (c) Operated within a retail grocery.

The facility no longer has a certified food safety manager.

A minimum of one certified manager must be employed at public food service establishments to ensure proper food safety practices are being followed.

To correct: A least one employee must become a certified food safety manager with in the next 90 days. A proof of correction is required.
